RECOMMENDED ACTION

Approve Bulletproof Vest Partnership FY 2009 Grant in the amount of \$11,158.88 and approve a budget adjustment to revenues and expenditures in the amount of \$11,159.

EXECUTIVE SUMMARY

On June 24, 2009, the City applied for a Bulletproof Vest Partnership Grant through the Bureau of Justice Assistance. This grant reimburses 50% of the cost of vests purchased on or after April 1, 2009 through September 30, 2011, or until all available award funds have been requested. Vests must meet the National Institute of Justice standards for body armor on the date ordered. The application requested funds in the amount of \$11,159 for 50% replacement for 45 vests, which included 24 vests with expiring warranties, 10 vests for new officers to be hired due to annexation, and 11 vests for projected turnover in personnel during the grant period.

On October, 6, 2009, the City was notified that a grant had been awarded in the amount of \$11,159. Matching funds are available in the budget for the Patrol Division.
