This Addendum provides clarification to portions of the Request for Qualifications (RFQ) No. 2010-5.

1. On Page 9 of 16, Paragraph 3.3.1, change “Paragraph 2.8” to “Paragraph 2.9”.
2. Reference the Design-Build Respondent’s Questionnaire – Any attachments to the questionnaire that are required to provide a complete response shall not count towards the twenty (20) page limit. These attachments should be kept to a minimum.
3. All Respondents shall complete the attached FORM CIQ – CONFLICT OF INTEREST QUESTIONNAIRE in accordance with Chapter 176, Local Government Code and include in their submittal. One form must be completed for each local government officer with whom the filer (Respondent) has an employment or other business relationship as defined by Section 176.001(1-a), Local Government Code. Negative responses are required. This form shall not count towards the twenty (20) page limit.

CONFLICT OF INTEREST QUESTIONNAIRE

For vendor or other person doing business with local governmental entity

This questionnaire reflects changes made to the law by H.B. 1491, 80th Leg., Regular Session.

This questionnaire is being filed in accordance with Chapter 176, Local Government Code by a person who has a business relationship as defined by Section 176.001(1-a) with a local governmental entity and the person meets requirements under Section 176.006(a).

A person commits an offense if the person knowingly violates Section 176.006, Local Government Code. An offense under this section is a Class C misdemeanor.
