DEFERRED DISPOSITION (PROBATION)

Deferred disposition or probation can be used to have a case dismissed to avoid a conviction. Using this form, you can request probation in person at the court window or by mail without appearing in court before the judge. Probation cannot be requested online. If you are eligible, you can request probation by signing this form and submitting the form to the court before the appearance date on your citation along with payment of the required costs (see the court website or call the court for the amount). You must also send a copy of your valid driver's license (unless you are requesting probation on a charge of Driving While License Invalid) and a copy of your insurance card or other proof of financial responsibility naming you as a covered driver. At the end of probation, compliance documents can be submitted without a court appearance before the judge.

You are NOT ELIGIBLE for probation if:

1. You have a commercial driver's license (CDL) or if you had a CDL at the time of the alleged violation;
2. The violation is alleged to have occurred in a construction zone with workers present.

You are NOT ELIGIBLE to use this request for probation and must appear in court to request probation if:

3. You are requesting probation for any violation other than a moving traffic violation, Fail to Maintain Financial Responsibility, or Driving While License Invalid;
4. You do NOT currently have liability insurance coverage in which you are named as a covered driver;
5. You were under 17 years of age at the time of the alleged violation;
6. You are currently on deferred disposition (probation) in ANY court.

REQUEST FOR DEFERRED DISPOSITION (PROBATION)

I am requesting probation in this matter. I do solemnly swear or affirm that the following statements are true and correct:

- I hereby waive my right to trial by jury and to discovery. I hereby enter a plea of no contest to the violation shown above.
- I am the person named in the above referenced citation.
- I was at least 17 years of age at the time of the alleged offense.
- I possess a valid Driver's License. A copy is attached OR I am requesting probation for DWLI and will submit a valid driver's license, permit or occupational license at the end of my probation.
- I do not possess a Commercial Driver's License (CDL) and I did not possess a CDL at the time of this violation.
- I possess a valid automobile liability insurance policy and I am named as a covered driver on the insurance policy. A copy of my proof of insurance is attached.
- The offense did not occur in a construction zone.
- I am not charged with driving 25 mph or more over the posted speed limit.
- I am submitting the costs and special expense fee required by the court with this request.
- I understand that if I violate the terms of the court's order placing me on probation or if I fail to report my compliance as required, a conviction will be entered against me and will appear on my driving record.
